48. PARISH COUNCIL PARKS (Doncaster Avenue Recreation Ground/Springfield Park)

The Clerk reported on the following matters:

I. Doncaster Avenue Recreation Ground: EBC play inspection report received

Over a number of years, EBC had arranged an annual inspection of play items on Doncaster Avenue Recreation Ground and issued a report to the Parish Council, despite being reminded each time that inspections were already taking place as the Parish Council owned and maintained the land.

The Parish Council arranged daily visual checks, quarterly 'operational' inspections and an annual inspection at a cost £346 + VAT per year for the park.

EBC had recently forwarded another annual inspection report, which showed that inspection costs continued to be duplicated by the Borough Council.

RESOLVED: that the Clerk inform Mr P Wright (Director of Operational Services) of the situation

II. DARG: Swing Basket
