## 38. PARISH COUNCIL PARKS (Doncaster Avenue Recreation Ground/Springfield Park)

The Clerk reported on the following matters and noted that vandalism had remained low over the Summer months.

- I. Arrangements had been made to remove the litter bin situated in close proximity the train on Doncaster Avenue Recreation Ground (DARG). A replacement bin was in storage and would soon be positioned nearer to the new play area.
- II. The entrance gate and play area gate at Springfield Park had recently been inspected and a quote was awaited to establish what work was required to ensure the gates closed smoothly and rubber stoppers were replaced.
- III. The Clerk had met with the Tree Surgeon to establish priorities for work in the closed churchyards. An itemised quote for work was awaited.
- IV. Volunteers would again plant daffodil bulbs on the embankment by the library car park and also hoped to finalise work to remove ivy at Padmore Moorings.
  - Councillors were invited to join the volunteers on Saturday, 29 September 2018.
- V. Some fence panels to the wildlife area at the top of Springfield Park had been damaged over the Summer months. The area was not used by the public and plans to improve the area could be considered for the following year.
- VI. The outer casing to the Track Rider mechanism on DARG needed replacement. A customised part was on order from outside the UK, but was expected to be fitted the following week. The installation fee of £1,071 had been waived.
- VII. A new information sign had been produced and installed near the BMX track by a resident who had arranged a replacement through his signage company. The Clerk was asked to thank the resident on behalf of the Parish Council for his donation.
